



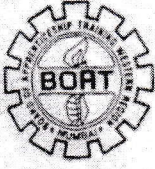

Subject: Effective implementation of National Apprenticeship Training Scheme (NATS) for engineering graduate and diploma holders in the aspirational districts under The Apprentices Act, 1961.

Sir,

You are aware that, Board of Apprenticeship Training (Western Region), Mumbai, is an autonomous body of Ministry of Education, Government of India, which implements the National Apprenticeship Training Scheme (NATS) for graduates / diploma holders of Engineering/Technology, Pharmacy, Hotel Management and Catering Technology, and Architecture under The Apprentices Act, 1961 (as amended from time to time). The area of purview of this Board for the implementation of the said scheme is the western regional states of India viz. Maharashtra, Goa, Gujarat, Madhya Pradesh, and Chhattisgarh as well as the Union Territories of Diu and Daman, and Dadra and Nagar Haveli.

Under this scheme the apprentices are trained by industries / establishments notified by this Board in various sectors / businesses. The apprenticeship training is imparted in the form of 'on the job training' in which learning by doing is practiced so that the apprentices not only acquires technical skills in the domain of their qualifications but also behavioral skills. The duration of apprenticeship training is one year and during the training the establishment shall pay a stipend to the apprentices at the prescribed rate of Rs. 9000/- for graduate apprentices and Rs. 8000/- for diploma apprentices. It is pertinent to mention that 50% share of stipend at the prescribed rate is reimbursed by Government of India to the industries / establishments imparting training to apprentices. On successful completion of one year of training the apprentices are awarded with a Certificate of Proficiency. This one year of Apprenticeship training is also counted as one year of job experience.

Recently, Ministry of Education has also mandated BoPT / BOATs for implementing National Apprenticeship Training Scheme for general stream graduates such as B.A., B.Sc., B.Com. The webportal module for carrying out the procedure of implementation in regard to these graduates is under way and at present the same is being done manually.

Ministry of Education, Government of India, has already deployed a National web portal with URL www.mhrdnats.gov.in for implementation of the NATS. This portal provides online services related to implementation of apprenticeship training of Graduate, and Technician Apprentices. The interested Industries / Establishments, Institutes and fresh passout aspirants of apprenticeship training can enroll on the NATS portal and avail the benefits of the scheme.

Ministry of Education, Government of India, has instructed to strengthen the implementation of NATS in the Aspirational Districts by way of sensitization and mobilization of the stakeholder. You are therefore, requested to disseminate this information to the Government organization, viz institutions, and industry in Gadchiroli district and inform them to get in touch with the Shri P.H. Ukey, Assistant Director of Training, (Mobile No.9096108333) concerned officer in-charge at BOAT (WR), Mumbai, for necessary guidance on implementation of NATS. Further, in this regard we also request you to facilitate for conduct of events for furtherance of the NATS, through your good office.
