- 6. As a teacher of Commerce you will have to teach the subject allotted to you by the Principal as per Time-Table and also you will have to do other extra co-curricular activities allotted to you by the Principal.
- 7. If you want to leave the job you will have to give one month notice or you will have to pay one month's salary in lieu of notice period. The same condition will be applicable to the employer also.
- 8. You will not do any part-time work anywhere or you will not join any college without the prior permission of the Management.
- 9. You will not associate with organization of Economic and Political nature.
- 10. You will have to be regular and punctual in the college.
- 11. You will be co-operative with the members of Teaching and Non-Teaching staff and you will not do such work which will vitiate the discipline and congenial atmosphere of the college.
- 12. You will always help the authorities in maintaining discipline in the college, on the Playground and in the campus also.
- 13. You have to undergo a medical examination by Govt. Medical Officer within three months from the date of appointment.
- 14. You have to join your duties within a week otherwise this order shall stand cancelled.
- 15. Your appointment will come in to force from the date you join the duties.
